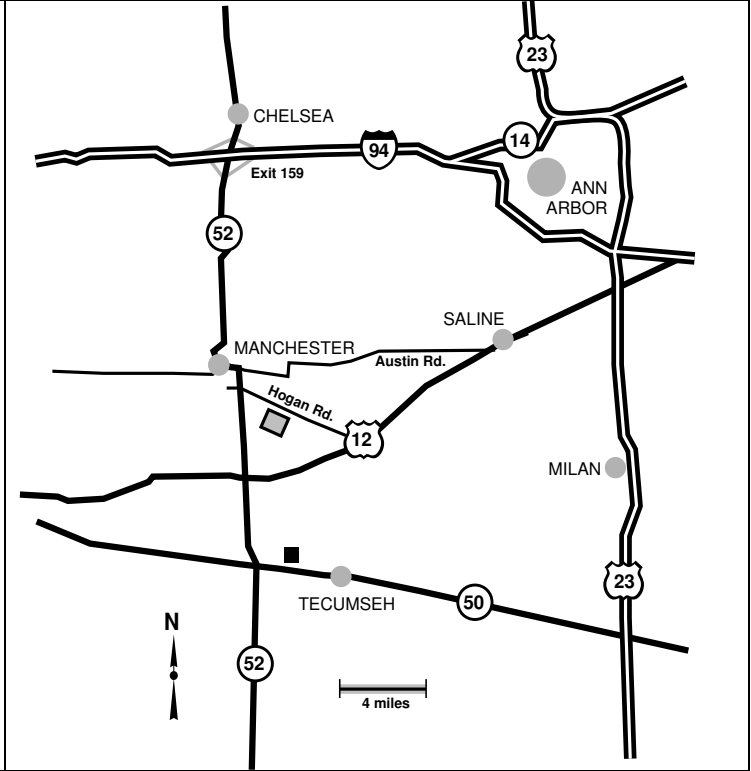

### RANCH TRIAL COURSE DESCRIPTION

1. Take 10 sheep from barn yard to round pen
2. Proceed through 2 small pens and into 15-acre pasture.
3. Drive or fetch sheep around trees and through gate to 2-acre pasture.
4. Load sheep into and out of stock trailer.
5. Return to barnyard, load into sorting chute
6. Sort off five marked head and put five back into round pen.
